- **Mystery Shopper Program:** Boosted customer satisfaction by **22%** via anonymous feedback & real-time dashboards.
- **Internal Excellence Award:** Cut costs by **95%**, honoring **9 individuals & 3 departments** (e.g., 20:1 license ratio).
- **Specialized Strategies:** Slashed cargo clearance time by **30%**, achieving **77% of 2024 goals**, lifting Dubai to **11th global maritime rank**.
- **Risk Mitigation:** Reduced high-impact risks from **52% to 11%**, saving **AED 4.2M** via automation/workshops.
- **ISO Compliance:** Secured **ISO 44001**, advanced **ISO 56002**, zero non-conformities in **50+ audits**.
- **Innovation Week:** Co-developed **Dubai Ports Code** with ARUP, projected **15% port cost cut by 2030**.
- **Operational Efficiency:** Automated **45 processes**, hit **98% work completion**, slashed HR onboarding to **5 days**.
- **Community Impact:** Launched **27% more initiatives: 1,200 STEM students, 8-ton marine cleanup**.
- **Awards:** First PCFC woman to win **TITAN Gold**; secured **Stevie Awards & Maritime CSR Award**, making PCFC UAE's **1st CSR world leader**.

As a pivotal leader within the Strategy and Institutional Governance Directorate, my contributions in 2024 directly advanced the Corporation's strategic goals, operational excellence, and global stature. Below is a concise overview of my achievements in leadership, innovation, and impact:

1. Strategic Initiatives: Elevating Service Excellence

I spearheaded the **Mystery Shopper Program**, a 2024 initiative to assess service quality through anonymous customer evaluations. By training evaluators and integrating real-time feedback into dashboards, the program identified 32 improvement areas, driving a **22% increase in customer satisfaction scores** within nine months. Concurrently, I designed the **Internal Excellence Award**, a zero-cost, data-driven recognition system that eliminated subjective evaluations. Leveraging existing performance metrics, it autonomously identified top performers, reducing administrative costs by **95%**. The inaugural awards recognized **9 individuals** (e.g., staff who cut turnaround times by 40%) and **3 departments**, including the Licensing Unit, which achieved a **20:1 ratio of new-to-expired vessel licenses**.

2. Strategic Governance and Performance

As architect of the **Specialized Strategies Methodology**, I aligned corporate goals with unit-specific initiatives. For example, the Customs Unit adopted a risk-based inspection framework, slashing cargo clearance times by **30%**. This methodology contributed to **77% achievement of 2024 strategic objectives**, including an **86% on-time delivery rate**—a corporate record. During the **2021–2025 Strategic Plan** review, I led 12 cross-departmental workshops, integrating feedback from 200+ employees. These insights informed the **2026–2030 Strategic Plan**, incorporating predictive analytics for challenges like digitization and climate resilience. My benchmarking efforts supported Dubai’s rise to **11th globally** in maritime competitiveness.

3. Risk Management and Compliance Excellence

In response to 2023 findings that **52% of enterprise risks were high-impact**, I orchestrated mitigation strategies, including **3 enterprise-wide workshops** mapping 150 processes and identifying 28 vulnerabilities. Automated fraud detection and vendor protocols reduced high-impact risks to **11%**, averting **AED 4.2 million in potential losses**. My compliance leadership ensured **zero major non-conformities** across 50 internal and 8 external audits. The Corporation also achieved **ISO 44001** (Collaborative Relationships) and advanced preparations for **ISO 56002** (Innovation Management).

4. Innovation and Future Readiness

Collaborating with the Dubai Future Foundation, I co-designed **Innovation Week**, exploring AI-driven logistics and decarbonization trends. My keynote workshop on strategic foresight engaged 50+ leaders, including H.E. Eng. Abdullah Belhoul, shaping the **Dubai Ports and Marinas Infrastructure Code**. Partnering with ARUP, we conducted 6 stakeholder workshops to establish emission controls and quay durability standards, projected to reduce port costs by **15% by 2030**.

5. Operational Efficiency and Social Impact

I streamlined workflows across 8 departments, automating 45 manual processes to achieve **98% work plan completion** and an **8% rise in documented procedures**. For instance, HR reduced onboarding time from 14 to 5 days using my digitized checklists. My community initiatives grew by **27%**, including a Dubai Cares partnership funding STEM programs for 1,200 students and a coastal cleanup removing **8 tons of marine debris**, aligning with UAE sustainability goals.

6. Awards and Leadership Recognition

I am the first employee and woman in PCFC who won the gold award in The TITAN Awards in the Architect of Strategic Excellence category, also my strategic vision secured the Corporation’s **Stevie Awards** for “*Executive of the Year*” and “*Business Technology Solutions*” and the the Maritime Standard CSR Award with an outstanding recognition in making PCFC as the 1st entity in the UAE to be recognized as an CSR world leader.. Internally, I mentored 5 junior staff to promotions, reflecting my commitment to talent development.

7. Conclusion: Visionary Leadership

My leadership—rooted in collaboration, data-driven decisions, and anticipatory governance—has driven transformative outcomes. By fostering innovation, mitigating risks, and prioritizing sustainability, I have solidified the Corporation’s reputation as a global benchmark. As we advance, I remain dedicated to leveraging technology and partnerships to sustain Dubai’s competitive edge. This portfolio exemplifies my commitment to excellence, making me a strong candidate for individual recognition in leadership and innovation.
