As a key player in the sector, it continues to operate with the goal of leaving a greener world for future generations.

AKLease, the supplementary power of growth, continues to provide its support on investments made by their customers for the future of Türkiye, with its 10 branches spread around Türkiye, its pioneering soul, its experience and without any interruptions.

AKLease's most important success in the industry: ECOLease which is the industry's first and only environmentally friendly product. ECOLease is the green financing product of AKLease, who gives importance to sustainability. It provides significant benefits to all companies, which contribute to renewable energy, waste management, energy efficiency, raw material efficiency, water efficiency and make investments which can be financed by leasing. In approximately 4 years, AKLease have financed environmentally friendly projects totaling 314 million dollars. AKLease have met the annual electricity needs of more than 350 thousand houses with the energy generated from these projects, with 280,000 t/CO2 emission reduction, it contributed to the nature as much as the contribution of over 13 million trees.

Another AKLease's success is Fleet Leasing. In the first quarter of 2023, AKLease established own fleet brand under AKLease. The name of the brand is AKLease Fleet. It offers solution partnerships to its customers with contracted services in more than half of Turkey.

AKLease closed 2024 strongly in its sector in both equity and asset profitability ratios. The company's year-end transaction volume was close to 6500 million. The majority of the investments in AKLease's portfolio are energy efficiency and green energy investments. It has a significant transaction volume in this field. To date, AKLease has provided approximately 600 MW of resources and a total of 445 million dollars of green financing to the renewable energy sector. ECOLease accounts for \$313 million of this.
