Amongst our products, Lodgerin offers a scalable solution that reduces costs and time for mid-term rentals allowed by our 360 software that automizes all processes.

Lodgerin is a startup with rapid growth created to simplify international mobility through accommodation services. Founded in 2022 by serial entrepreneur Óscar Rubio Martín, the software was born after a decade of experience in the real estate and mobility sectors. His trajectory began in 2011, after experiencing the first-hand difficulties of renting homes abroad, which led him to create projects such as People Global Relocation and Housing Markers.

Lodgerin was born as an integral technological solution that connects property owners, institutions, and service providers in a single digital ecosystem.

Currently, it offers a scalable solution for managing mid-term rental (1 to 12 months), reducing costs and time through its own technology: Arreto (PMS for property owners), Arribo (app for tenants), and Abroad (platform for institutions).

With strong differentials with other companies in the sector, Lodgerin integrates all rental processes in a single ecosystem. With operations in Europe, United Arab Emirates, and the United States, we combine an entrepreneurial image based on personal experience with a technological approach with high potential for impact.

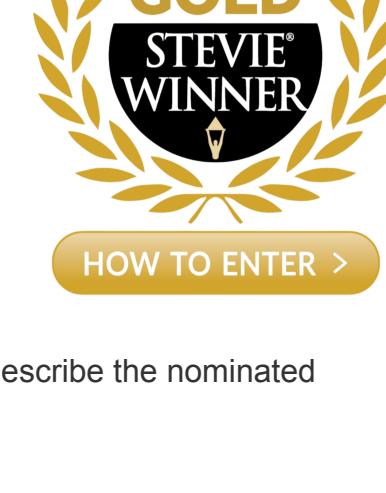
