Bitel, a subsidiary of Viettel Group, entered Peru’s telecommunications market in 2014 with a mission to expand high-quality connectivity to underserved and rural regions. In a sector long dominated by legacy operators, Bitel quickly positioned itself as a disruptive force by prioritizing inclusive network expansion. Within a decade, the company built one of the largest 4G infrastructures in the country and laid the groundwork for 5G, enabling it to reach nearly **9 million subscribers** and capture a **20.5% market share** by early 2025.

Bitel’s performance reflects consistent, sustainable growth. It has achieved strong financial results, including a **12.8% revenue increase in 2024** and an **EBITDA margin of 39.4%**, outperforming major competitors. The company’s impact also extends beyond connectivity. In 2022, it launched **BiPay**, the first and only e-wallet in Peru partnered with the Central Bank, now serving over **2 million users**, many in rural and student populations.

Through significant investments — including **USD 600 million** for rural infrastructure — Bitel has reinforced its commitment to digital inclusion and economic empowerment. From telecom newcomer to national growth leader, Bitel continues to redefine what’s possible in Peru’s digital landscape.

Since early 2023, Bitel has solidified its position as the fastest-growing telecom company in Peru, achieving both financial and operational milestones while advancing its mission of inclusive connectivity.

Financially, Bitel recorded a **12.8% revenue growth**, rising from **PEN 1.438 billion in 2023 to PEN 1.734 billion in 2024**. Its **EBITDA margin reached an impressive 39.4%**, outperforming Telefónica (-16.99%) and Entel (25.66%), positioning Bitel as a benchmark in financial resilience and efficiency.

Operationally, the company launched the **Amazon Project**, which connected **over 50,000 residents across 3,825 rural localities**—one of the largest rural connectivity efforts in the country. Backed by a **USD 600 million infrastructure investment**, Bitel accelerated the expansion of both 4G and 5G coverage, bringing high-speed mobile services to underserved populations and contributing to national digital inclusion goals.

In parallel, Bitel advanced **financial inclusion** through **BiPay**, its proprietary e-wallet solution. BiPay reached **2 million users** within two years, especially in rural and student segments, and remains the only digital wallet in Peru backed by the Central Bank.

These achievements underscore Bitel’s dual focus on **sustainable growth and social impact**, reaffirming its role not just as a telecom operator, but as a driver of economic empowerment in underserved regions of Peru.

Bitel’s growth achievements since 2023 are significant not only for their scale, but for their **strategic impact in reshaping Peru’s telecom landscape**—especially in rural and underserved regions historically neglected by legacy operators.

While other players focused on urban profitability, Bitel directed its efforts toward **inclusive, long-term growth**, achieving a **12.8% increase in revenue** and an **EBITDA margin of 39.4%** in 2024. In contrast, Telefónica recorded a negative EBITDA margin of -16.99%, and Entel reported 25.66%, highlighting Bitel’s **superior cost management, operational efficiency, and market responsiveness**. Compared to its own performance in prior years, Bitel’s 2024 EBITDA is the company’s highest to date—underscoring its ability to scale profitably while investing aggressively in infrastructure.

The **Amazon Project**, connecting **over 50,000 isolated Peruvians** across **3,825 rural locations**, is unprecedented in the country and demonstrates a **bold commitment to digital inclusion**. Meanwhile, **BiPay**, Bitel's digital wallet, reached **2 million users** and became the **only e-wallet in Peru authorized by the Central Bank**, targeting financial inclusion in rural and student populations where traditional banking penetration is minimal.

No other telecom operator in Peru has matched Bitel’s combination of **financial resilience, rural infrastructure investment, and social impact at scale**. These accomplishments mark a fundamental shift from being a market challenger to becoming **a national leader in both connectivity and innovation**, driving inclusive digital and economic progress.
