Archaana Pattabhii is a visionary financial technology executive transforming how global banks operationalize AI, govern risk, and modernize compliance. As Senior Vice President at she leads Data Engineering Controls for the \$27.88B PBWM division—one of the bank's most regulated and strategic units.
She designed enterprise-wide control infrastructure spanning 500+ platforms, delivering a 37% reduction in ineffective controls, 88% faster remediation, and millions in annual savings. She pioneered Al-enabled Control Center, enabling real-time risk scoring and automated attestation. Ar
Ranked in the top 1.6% globally in Al Accelerator Program and nominated to the iLead executive pipeline, Archaana has earned Gold awards from Titan Business and Globee for innovation in Al, along with a Global Recognition Award in fintech.
She contributes to national AI governance efforts through collaboration with the San Diego Supercomputer Center and MIT Professor D . Jim Short, co-leading a policy framework for responsible AI. She is also a featured speaker at the MIT CDOIQ Symposium on July 14, 2025.

What distinguishes her is the rare ability to orchestrate regulatory transformation at enterprise scale while simultaneously pioneering AI governance frameworks that are being replicated globally.
While many leaders implement reactive data controls, Archaana architected I-enabled Risk Command Control Center, a predictive risk intelligence platform that transforms static compliance into dynamic, real-time assurance. Most institutions struggle to meet regulatory timelines; under her leadership, Citegoreleated remediation cycles by 88%, reduced ineffective controls by 37%, and delivered \$3M in annual savings which is scalable across different lines of business and figures that far exceed industry benchmarks.
Her selection to both Al Accelerator Program (top 1.6% globally) and its exclusive iLead executive pipeline is further validation of her position among the firm's most elite digital leaders. Compared to her own prior performance, these recent milestones reflect an inflection point: Archaana has shifted from driving individual transformation programs to shaping global strategy for Al risk and control assurance.
In a sector where regulatory missteps are costly and innovation is tightly constrained, Archaana has delivered both excellence and innovation. Few executives at her level lead flagship panels alongside the FBI, win multiple global awards, and publish thought leadership in Forbes,
