Incskill (Previously I-Stem) (Techstars 2024 and Forbes 30 under 30 2025) has been at the forefront of transforming how businesses approach accessibility. Our suite of tools helps companies create more accessible products for their customers and employees with disabilities. Through continuous innovation, we have made significant strides in product design & development, corporate social responsibility, and information technology, reshaping the accessibility landscape for organizations worldwide.

1. Product Design & Development

At Incskill, our core innovation lies in the development of an automated AI accessibility testing engine. You can think of it as "Grammarly for Accessibility". This powerful tool periodically scans websites and documents to detect accessibility violations, ensuring continuous compliance with global accessibility standards like WCAG. Unlike traditional manual audits, our engine provides real-time, automated insights, significantly reducing the time and resources businesses need to maintain compliance.

In addition to website and document scanning, we have expanded our product offerings to include integration tools that seamlessly connect with popular content management systems (CMS), intranet platforms, and enterprise software. This ensures that both customer-facing products and internal employee tools are equally accessible. Our dashboard offers detailed reporting and actionable insights, enabling businesses to prioritize and remediate issues efficiently.

2. Corporate Social Responsibility (CSR)

Since 2022, we have partnered with non-profit organizations and educational institutions to promote awareness and best practices around digital accessibility.

- For example, in collaboration with the State of Washington's Department of Services for the Blind, we provided comprehensive computer science training programs tailored to individuals who are blind, low vision, or DeafBlind. For instance, through the Chat for Impact: GenAl Accelerator, in collaboration with OpenAl, we launched an innovative WhatsApp service designed to provide real-time accessibility support, showcasing our ability to integrate cutting-edge Al technologies into practical, user-centric solutions.

Since our launch, Incskill has helped over 150 organizations improve their digital accessibility, impacting the lives of thousands of users with disabilities.
