#### Driving Policy Change Through Strategic Communication

Indosat's AI Sovereignty initiative underscores AI's role in national progress, boosting workforce productivity by 3.5% and GDP by up to 6.9% annually. Through a well-crafted public affairs strategy. Indosat has positioned AI as a catalyst for economic and social transformation.

At the core of this success is an approach that bridges corporate, government, and societal interests. Engaging with regulators, Indosat advocates for Al-friendly policies aligned with national goals. The company has facilitated high-level discussions, including closed-door briefings and public forums, educating policymakers on Al's potential.

Indosat ensures businesses, educators, and the public understand Al's benefits, fostering national awareness and investment.

#### Strategic Partnerships for Al Adoption

Beyond advocacy, Indosat drives AI adoption through key initiatives. Partnering with NVIDIA, Indosat launched Indonesia's first sovereign GPU Cloud service, enabling high-performance AI computing for enterprises and government agencies. This strengthens national AI infrastructure.

The AI Experience Center at Solo Technopark, developed with Huawei, fosters AI training, innovation, and policy discussions. Indosat also launched GPU Merdeka, an AI Cloud and GPU-as-a-Service platform with Lintasarta and NVIDIA, accelerating AI adoption across industries.

Indosat's efforts culminated in a historic announcement where Minister of Communication and Digital Affairs, Meutya Hafid, endorsed AI Centers across Indonesia.
