The first version of ADA was introduced in October 2017 and the new one in December 2022.

ADA is a customizable serious game that turns the employee onboarding process into an exciting and fun experience capable of involving all employees.

"The year is 2127. A post-apocalyptic world. Civilization as we know it has disappeared. The dark shadow of extinction hangs over humanity. And you are our only hope for saving the last survivors of a species on the brink of extinction."

This is the scenario the user encounters in this adventure packed with challenges, tests and obstacles, in which knowing their new company becomes vital for achieving the great objective: saving humanity.

ADA was designed to increase the engagement and acquisition of knowledge and information in any onboarding process. It's a gamification tool designed to:

- Multiply engagement in the employee onboarding process with the use of storytelling, leaderboards, levels, and badges.
- Convey information uniformly and instantaneously to geographically diverse staff.
- Save in terms of time and costs.
- Shore up digital transformation.
- Communicate "innovation", "technology" and "fun" from the HR department.

ADA's content manager lets administrators design their own video game with whatever content they want to include: information in text, presentation, video, and audio formats. Administrators can create as many versions of the video game as they want. And it's as easy as simply dragging and dropping documents into the editor.

Users only need an internet connection to access ADA through the Gamelearn platform, which can also be integrated into the company's LMS as an additional solution. ADA is available in Spanish, English, French, Portuguese, German, and Dutch.
