This focus has positioned us as trusted partners to the world's largest IT and cybersecurity brands, including Palo Alto Networks, Check Point, Nutanix, AWS, Fortinet and others. Since our founding in 2005, we've trained more than 90,000 professionals across Asia Pacific, the Americas, Europe, and the Middle East.

What makes us different is the calibre of our instructors and the quality of our custom-built virtual lab environments, which simulate real-world software deployments. Certification training outcomes are validated through a consistent 4.8/5-star rating from over 5,000 student reviews. This feedback fuels our Kaizen-driven improvement culture.

Red Education instructors are globally recognised, with several awarded Instructor of the Year titles by vendors, including Jerry Solomon, Palo Alto Networks JAPAC Instructor of the Year 2024. Our labs, built on over 40,000 lines of internal Python code, replicate real-world enterprise environments to deepen student capability and reduce post-training implementation risks.

They are now available for independent weekly hire, offering continuous learning, revision, and experimentation beyond formal course dates.

Instructor quality is another standout feature. Red Education instructors are industry experts and must be great communicators.
