Wind Energy: LandGate's Wind Value Index provides a comprehensive view of each parcel's potential for wind energy projects.

EV Charging: The EV Charging Index is a specialized tool designed to assess and score the suitability of land parcels for developing electric vehicle (EV) charging stations.

Available Power: LandGate measures the value of a parcel's access to sufficient available power from the electrical grid by studying nearby, accessible power sources and electrical infrastructure, as well electricity supply and demand within the local grid of the selected parcel.

Minerals: Typically it takes a technical understanding to know whether mineral rights are valuable or not.
