EnFuse, appointed by the State government as the System Integrator for over 7,000 PACS in Maharashtra, plays a crucial role in this endeavor.

Anuja guided the template creation and facilitated quality assurance for the bulk upload and validation tool. This innovation increased productivity by reducing the lead time for each PACS by 180%, a drastic enhancement unmatched by any other employee.

She also formulated the L1 team, resolving issues before escalating them to stakeholders. This initiative reduced escalations by 60% and improved query resolution lead time by 36%, outperforming other teams.

Anuja implemented bi-weekly stakeholder updates, maintaining trust and transparency through regular visits to the Client offices, setting a high standard in communication.

Additionally, Anuja meticulously tracked parking account creation, ensuring no such accounts were created in EnFuse-aligned districts. When unavoidable, she informed the RO about incorrect practices, leading to 100% qualitative input in the system for all PACS assigned to EnFuse.
