As a seasoned solution architect, he delivered seamless integrations between SAP and Blue Yonder systems for both transactional and master data needs while ensuring minimal disruption to daily operations.

Prahlad architected seamless integrations between SAP ECC and Blue Yonder systems (including Luminate Demand Edge, Fulfill, WMS, and TMS), creating robust connections for the new BJ's Fresh Link vendor collaboration platform that replaced Burris' homegrown systems. His expertise enabled successful transitions at distribution centers in Rocky Hill, CT; Orlando, FL; Elkton, MD; and Independence, KY.

His solution architecture supported CEO Bob Eddy's strategic vision to "insource capabilities to support future growth" while maintaining uninterrupted service to 225 clubs across 17 states. Prahlad's integration framework facilitated smooth onboarding of Burris team members and maintained continuity of perishable product distribution that had been in place for over 20 years.

Through methodical risk identification and mitigation, Prahlad ensured data quality and system compatibility throughout the integration process.
