SAI360 is a global leader in integrated risk, ethics, and compliance technology. Originally formed in 2003 when Standards Australia divested its commercial operations, SAI360 has evolved into a standalone software company headquartered in Chicago, serving customers in 50+ countries. The company's platform supports highly regulated sectors—including financial services, healthcare, manufacturing, and life sciences—by integrating ethics, governance, risk, compliance (GRC), into one unified experience.

After being acquired by Baring Private Equity Asia in 2016, SAI360 sharpened its strategic focus through the 2021 divestiture of its Standards & Assurance division. This enabled deeper investment in platform innovation, customer experience, and AI-powered capabilities. The company now serves one-third of the Fortune 500 and supports over 1 million users annually.

SAI360 is recognized by industry analysts including Verdantix, G2, Forrester, and Brandon Hall for its product innovation and leadership. With 25+ years of experience, SAI360 continues to help customers operationalize compliance, reduce risk, and foster ethical cultures—all while adapting to an increasingly complex global risk landscape.

Since January 2023, SAI360 has expanded and redefined its GRC and ethics and compliance education capabilities across two fronts: advanced technology and measurable learning impact.

The launch of Horizon Scanning represents a breakthrough in real-time, AI-powered risk education. Developed in partnership with Signal AI, Horizing Scanning integrates dynamic external risk data—such as geopolitical shifts, regulatory changes, and supply chain threats—directly into the SAI360 platform. This allows governance, risk, and compliance professionals to detect and respond to emerging threats faster, integrating external intelligence with internal policy, training, and risk frameworks.

SAI360's learning platform has also scaled rapidly. It now supports ethics and compliance training for over 5 million employees annually, with delivery in 60+ languages. The expanded content library includes adaptive training, microlearning modules, and new programs addressing global regulations, behavioral risk, and ESG topics. All are delivered through flexible LMS integrations and backed by real-time analytics.

These innovations are matched by results: In 2024, SAI360 received 11 G2 badges across GRC and Learning categories and earned eight Brandon Hall Awards for excellence in compliance training. New executive leadership in product, customer success, and technology has further accelerated platform development and user experience enhancements.

Together, these achievements represent not just product progress—but a broader commitment to embedding ethics, compliance, and risk awareness directly into the rhythm of everyday work.

The platform tracks engagement, risk areas, and completion rates in real time, helping ethics and compliance leaders demonstrate ROI and prepare for audits, board updates, and regulatory inquiries.
