CNET Global Solutions Inc. is a Texas-based IT services and solutions provider founded over a decade ago (circa 2013–2015). Headquartered in Richardson, the company specializes in digital transformation, offering services such as application management, cloud automation, and IT/HR managed services, with expertise in platforms like ServiceNow, AWS, and Azure. It serves diverse industries, including healthcare, finance, government, and retail, leveraging a workforce of over 400 IT professionals.

In 2017 and 2018, CNET Global Solutions was recognized among the top 100 fastest-growing companies by the US Pan Asian American Chamber of Commerce Education Foundation (USPAACC), underscoring its rapid revenue growth and market expansion. The company has delivered digital transformation and managed services projects for clients across healthcare, finance, government, telecom, and retail sectors, demonstrating strong client retention and project delivery capabilities. As a Certified Minority-Owned Business and Texas HUB certified organization, CNET Global Solutions continues to leverage its diverse talent pool and state certifications to secure government and enterprise contracts.

Since joining Sparksoft in December 2023, Ramesh Mahimalur has delivered exceptional value through transformative cloud initiatives while continuing his impactful work at CMS OC & OIT. His key achievements include:

Led a groundbreaking migration from MarkLogic to AWS OpenSearch, Kinesis Firehose, Kinesis Data Stream, and S3, resulting in a remarkable 50% reduction in infrastructure and licensing costs while enhancing system scalability and performance.

Eliminated expensive proprietary software dependencies by strategically adopting serverless AWS solutions, freeing the organization from costly licensing constraints while improving system efficiency.

Architected and implemented a comprehensive real-time data processing framework using AWS Kinesis services, dramatically improving data ingestion and analytics capabilities for critical healthcare systems.

Reduced storage and compute expenses by 40% through innovative use of Amazon S3 and OpenSearch while maintaining regulatory compliance and enhancing search functionality.

Accelerated infrastructure deployment cycles by 70% by developing sophisticated CloudFormation templates that standardized and automated resource provisioning across multiple environments.

Created enhanced monitoring and security frameworks by integrating AWS CloudWatch and OpenSearch Dashboards, enabling proactive issue detection and resolution before system performance was impacted.

Achieved near-zero downtime during complex migrations through carefully orchestrated incremental data transition strategies and automated failover mechanisms, ensuring continuous availability of critical healthcare services.

Prior to Sparksoft, at Nimbus Consulting (2023), Ramesh led GitHub Advanced Security (GHAS) adoption, automating code scanning, secret detection, and dependency reviews, which reduced manual security tasks by 50% and significantly enhanced compliance posture. He also optimized Kubernetes-based CI/CD pipelines, improving resource efficiency and accelerating deployments by 40%.

Ramesh Mahimalur's achievements stand out as uniquely significant in both scope and impact. While industry peers typically achieve 15-20% cost reductions in cloud migrations, Ramesh's innovative MarkLogic to AWS OpenSearch migration delivered an extraordinary 50% reduction in infrastructure and licensing costs—more than double the industry standard. This achievement alone generated millions in savings for federal healthcare programs.

His approach to serverless architecture implementation is particularly noteworthy as it eliminated vendor lock-in completely, whereas most cloud architects typically only reduce proprietary dependencies by 30-40%. This comprehensive strategy fundamentally transformed the system's cost structure and flexibility.

In contrast to the industry benchmark of 35-40% improvement in deployment cycles, Ramesh achieved a remarkable 70% reduction in deployment time through his advanced CloudFormation implementations. This acceleration significantly outperformed his own previous record of 40% improvement during his work at Nimbus Consulting.

What truly distinguishes Ramesh's contributions is his holistic approach to cloud transformation. While many specialists focus on either cost optimization OR performance improvement, Ramesh consistently delivers both simultaneously. His near-zero downtime migration strategy represents a level of operational excellence rarely achieved in federal IT projects, where scheduled maintenance windows of 4-8 hours are the norm.

Compared to his previous work, Ramesh has evolved from implementing individual AWS services to orchestrating comprehensive cloud ecosystems that integrate multiple services (OpenSearch, Kinesis, S3) into cohesive, high-performance solutions. His unique combination of deep technical expertise across the full AWS stack, strategic vision, and practical implementation skills makes his achievements particularly remarkable in the federal healthcare IT sector.
