Black Duck® was originally established in 2014 as a division of Synopsys called the Software Integrity Group. Through rapid organic growth and a series of strategic acquisitions, the Synopsys Software Integrity Group quickly emerged as a leader in the application security space. In October 2024, the Software Integrity Group officially separated from Synopsys as an independent company and rebranded as Black Duck.

Today, Black Duck meets the board-level risks of modern software with True Scale Application Security, ensuring uncompromised trust in software for the regulated, AI-powered world. Only Black Duck solutions free organizations from tradeoffs between speed, accuracy, and compliance at scale while eliminating security, regulatory, and licensing risks. Whether in the cloud or on premises, Black Duck is the only choice for securing mission-critical software everywhere code happens.

Additionally, Black Duck has been recognized by Gartner® as a Leader in the Magic Quadrant™ for Application Security Testing for seven consecutive years, ranking highest for Ability to Execute and Completeness of Vision for five years in a row. Black Duck has also been recognized as a four-time Leader in the Forrester Wave™ for Software Composition Analysis and a three-time Leader in the Forrester Wave™ for Static Application Security Testing.

Launched Software Risk Manager, a powerful new ASPM solution enabling security and development teams to simplify, align, and streamline their AppSec testing across projects, teams, and AppSec testing tools

Partnered with Secure Code Warrior and NowSecure to complement our portfolio.

Black Duck has differentiated itself as the undisputed leader in the software security industry, as evidenced by its growth, market share, and industry accolades. Black Duck earned the highest market share (31.2%) in the application security testing market according to Gartner’s “Market Share: All Software Markets, Worldwide, 2023.” Black Duck additionally received the highest scores for all five use cases in the 2022 and 2023 Gartner® Critical Capabilities for Application Security Testing.

Tom Herrmann, Black Duck’s VP of Global Channels and Alliances, received the CRN® Channel Chiefs award in 2022, 2023, 2024 and 2025 for rapidly establishing and growing a successful channel partner program consisting of more than 600 partners in 80 countries who have contributed to consistent double- and triple-digit year-over-year growth.

From the strategic partner standpoint, becoming an independent organization has allowed more flexibility throughout our program, emphasizing a “partner-first” strategy for our business. We also now conduct more than 30% of our business globally through the channel, with some regions conducting up to 100% of all business through partnerships.

Black Duck also supports a wide range of customers, including 51% of the Fortune 100, 6 of the top 10 financial services companies, 10 of the top 10 technology companies, and 10 of the top 10 global 500 automotive companies.
