ADC is a pioneering government entity dedicated to securing borders and facilitating seamless trade along one of the world's most strategic logistics corridors. Established in the early 20th century, ADC has evolved from a traditional customs agency into a global leader in digital innovation and border modernization. Over the past decade, ADC has reengineered its operations, adopting emerging technologies—such as blockchain, AI, and IoT—to deliver proactive risk management, end-to-end trade services, and fully digital border clearance. Its flagship initiatives, including the Invisible Customs Model, Digital Trade Corridors, Border Permits System, and the revolutionary TradeChain platform, have positioned ADC as a regional and international benchmark in digital transformation. Through its DigiNext 2024–2028 strategy, ADC restructured its IT operations into agile squads focused on cybersecurity, AI, integration, and digital experience—accelerating delivery and user-centric innovation. ADC aligns with global best practices, operating under frameworks such as TOGAF, ITIL, COBIT, ISO 27001/9001/20000, and DAMA. Backed by cloud-first infrastructure, Zero-Trust security, real-time disaster recovery, and AI-enabled service management, ADC has earned over 136 global awards and 27 ISO certifications, reaffirming its leadership in digital governance. The Invisible Customs TradeChain is its latest milestone, transforming customs from reactive enforcement to seamless, blockchain-powered trade facilitation.

TradeChain enables secure, tamper-proof data exchange among global stakeholders—customs, ports, logistics providers, OGAs, and traders—using intelligent automation to reduce clearance times, operational costs, and compliance risks.

Key Features:

- Blockchain-Secured Data: Tamper-proof, decentralized sharing of shipment, invoice, and inspection records.
- AI-Powered Risk Profiling: Pre-arrival risk prediction enables faster, smarter decisions.
- Smart Contracts: Automate regulatory compliance, clearance, and document validation.
- Pre-Authorization of Shipments: Allows customs clearance before goods reach the border.
- Full Ecosystem Integration: Connects customs, OGAs, ports, logistics providers, and traders in real-time.

Measured Impact:

- Processing Time/Transaction decreased from 20 to 6.1 minutes

- Pre-Arrival Processing: Increased from 6% to 72%
