Following an AI-first approach enabled by cloud- and data-first strategies, Encora has achieved an exceptional 46% CAGR over the past five years, outpacing several competitors. The Everest Group recognizes Encora as the fourth fastest-growing engineering services company and ranks it among the top 50 world tech companies. The company operates globally with 9,500+ professionals across 50 locations in the US, Latin America, Europe, the UK, India, and Asia Pacific and is supported by 40 innovation centers for rapid prototyping, MVP development, R&D and delivering at scale with expertise. Developed two groundbreaking AI offerings: (a) AI Factory enabling rapid experimentation, enablement, and scaling for clients like NetApp; (b) AI Adoption framework transforming engineering organizations with 20-100% productivity gains for Sagent, Defi, and others.

HiTech Vertical Expansion

Instrumental in expanding Encora's HiTech presence by establishing 350+ member engineering team for Tibco (Cloud Software Group), achieving 27% productivity boost with AI tools as one of the key levers.

Industry Headwinds & Strategic Response

During 2023-2025, the IT services industry faced unprecedented challenges from high interest rates, geopolitical wars, presidential year uncertainty, and subsequent tariffs. While competitors became revolving doors for sales teams, Rohit returned to the drawing board, creating innovative sales plays that massively boosted the sales funnel and maintained organic growth without unnecessary team churn.

Market-Defying Performance

Encora achieved 15-20% sequential growth while the industry remained flat or contracted. Leading providers struggled— one of our peers experienced shrinking revenues, was delisted and taken private for restructuring, while another suffered quarter-on-quarter declines, resulting in massive value erosion.
